WHEREAS, the date for bid opening was set for October 21, 2010 at 10:00 a.m.; and

WHEREAS, a total of two (2) bids were submitted pursuant to the bid request, to wit: Overhead Door Company of Batavia, \$13,200.00 and Batavia Garage Door, \$13,440.00; and

WHEREAS, on October 25, 2010 at a regular meeting of the Town Board for the Town of Albion the award for the aforementioned bid was unanimously awarded to Overhead Door Co of Batavia as the lowest responsible bidder; and

WHEREAS, accepting the Overhead Door Company of Batavia bid does not place said bidder at a substantial advantage or grant the bidder a benefit not enjoyed by the other bidders; and
